October Planting Days—A Big Thank You to the Boy Scouts and to **Lower Merion Township**

Although we couldn't advertise volunteer days to our general membership due to pandemic concerns, we were able accomplish some major planting anyway! First, we hired Master Naturalist consultant, Michelle Detwiler, to design our annual plan to plant native trees, shrubs, and perennials. The focus is to maximize ecological benefit and add to the beauty of our Park. We ordered 24 trees, 19 shrubs, and 18 perennials. On October 2, 2020, the Lower Merion Department of Parks & Recreation crew planted all of the perennials, shrubs and trees bought with your donation dollars, and also added 11 additional native trees provided by the Township.

Then the Bovs Scouts of Troop 176 took over! We ordered 194 additional perennials and on October 11, the Scouts (socially distanced of course) planted them for us. A few parent volunteers also pitched in. All of us Park users owe a big debt of gratitude to the Scouts and the Township for their hard work during this pandemic. THANK YOU SO MUCH!

Friends of West Mill Creek Park Is a Founding Member of Pollinator Pathways of Lower Merion

Pollinators and other beneficial insects and wildlife are critically important to our own life on the planet—and are in serious decline. Since its founding, the Friends of WMC Park has been dedicated to planting native species that provide food and habitat for these small creatures. But current science shows that helping nature to thrive in public parks alone is not enough. More space is needed to provide corridors of nature-friendly habitat so that these small

creatures can range from place to place. So, in 2020 the Friends of West Mill Creek Park partnered with the Lower Merion Conservancy, the Narberth Area Garden Club, and the Penn Valley Civic

Association to promote the new Pollinator Pathway of Lower Merion and Narberth. This project aims to establish a corridor of pollinator-and-stream friendly public and private properties in our

community. YOUR YARD can provide that crucial habitat and look lovely at the same time. It's easy to add your yard to the Pathway by adding native trees or plants and pledging to avoid use of harmful pesticides. You can also help spread the word by ordering an attractive Pollinator Pathways sign from the Lower Merion Conservancy.

For all you native plant geeks. . .

Here's a list of all the plants from the 2020 annual Fall Planting to look for as they leaf out this Spring:

Trees: American Hornbeam, Swamp White Oak, Black Willow, Bald Cypress, River Birch, Allegheny Serviceberry, and Smooth Alder

Shrubs: Arrowwood Viburnum, Bottlebrush Buckeye, Witherod Viburnum. and Spicebush

Perennials: Pink Turtlehead, Interrupted Fern, Tiarella, Barren Strawberry, and Striped Cream Violet.

If tennis-ball fetch of everyone. is important to you, please bring your own tennis balls to the Park and make every effort to take them home how disappointing it is to plan an outing at the park with you when you leave. Or, better yet, play fetch with a stick if your dog will cooperate. This precaution should drastically reduce the number of tennis balls washed into Mill Creek.

Plans for 2021

Plans are underway for the 2021 planting season. There will be a Spring planting that will focus on adding seasonal color and pollinator habitat to the Wildlife garden at the park entrance. Our new native flowering shrubs and perennials will include Virginia Sweetspire, Purple-flowering Raspberry, Black Cohosh, Bleeding Heart, Indian Pink, Jacob's Ladder, Golden Alexander, Fernleaf Phacelia, and Cardinal Flower. And of course, we also plan to add many new native trees and shrubs to the main park at our annual Fall Planting Day in October.

Whenever the pandemic allows, we plan to resume traditional social and volunteer events – though at this point it looks like that might not happen until 2022!

Friendly Reminders—PLEASE:

Clean up after your dog, whether the poop lands on the trail or elsewhere in the park. Your dog park friends' shoes and the wildlife in the stream will all benefit from your care!

Be respectful of our neighbors' property. The Park boundary at the far end of the park is now clearly fenced off and signs are posted to remind park users not to trespass. This has been a problem in the past year, so please be mindful and don't treat our neighbors' yards as an extension of the park!

Obtain an Off Leash Permit. It's easy to obtain an offleash permit from the Lower Merion Township website. The permit should be renewed for each calendar year and is open to residents and nonresidents alike. This permitting system aids the township in addressing a variety of issues, and getting the permit is a great way to show your support for the continued existence of our beloved dog parks.
